Resolution 6: That the Glen Eden Business Association receive and approve the draft Business Plan for the 1 July 2023 to 30 June 2024 financial year

Resolution 5: Move to approve the following financial year 2023/24 draft budget which includes a BID targeted rate grant amount of \$95,000 including a 0% increase to the BID targeted rate grant for 2023-2024 financial year. Further ask the Waitakere Ranges Local Board recommend to the Governing Body the amount of \$95,000 be included in the Auckland Council draft 2023-2024 annual budget consultation process.

**7. Appointment of Auditor for the year ahead**

Resolution 7: That the Glen Eden Business Association appoint William Buck as Auditor for the Glen Eden Business Association for the 2022/2023 financial year.

**8. Alteration of Rules**

Resolution 8 (Special Resolution) That the Glen Eden Business Association existing constitution (rules) document (dated March 2013) be replaced with the proposed new constitution (rules) dated September 2022 presented at the Annual General Meeting of the Glen Eden Business Association on 20<sup>th</sup> October 2022 and that such alterations be effected by replacing the existing constitution document (dated March 2013 ) with the proposed Glen Eden Business Association constitution (dated September 2022).

Reason: Amendments of the current constitution (rules) of the Glen Eden Business Association are required to ensure those rules pertaining to the BID programme and BID targeted rate grant are not inconsistent with the Auckland Council Business Improvement District (BID) Policy
