Resolution 1: That the Glen Eden Business Association receive and confirm the 2022 AGM Minutes of the Glen Eden Business Association (held on 25<sup>th</sup> October 2022).

Resolution 2: That the Glen Eden Business Association receive the 2022/2023 Chairperson's Report (being governance update and report on strategic achievements from the 1 July 2022 to 30 June 2023 financial year).

**5. Treasurer's Report**

Resolution 4: That Glen Eden Business Association receive and approve the written Treasurer's report and Annual Financial Statements for the Financial Year 1 July 2022 to 30 June 2023

Resolution 5: That the Glen Eden Business Association receive and approve the draft Business Plan for the 1 July 2024 to 30 June 2025 financial year

Resolution 6: Move to approve the following financial year 2024/25 draft budget which includes a BID targeted rate grant amount of \$103,550 including a 9% increase or \$8,550 to the BID targeted rate grant for 2024-2025 financial year. Further ask the Waitakere Ranges Local Board recommend to the Governing Body the amount of \$103,550 be included in the Auckland Council draft 2024-2025 annual budget consultation process.

**6. Proposed BID Expansion**

Resolution 7: (Special Resolution) That the Association endorses the investigation of a possible Business Improvement District (BID) boundary expansion to include commercial properties on West Coast Road (between numbers 351 and 375) and those in Waikaukau Road with possible ballot in 2024 subject to feedback from businesses in that area.

An update will be provided to the AGM.

**7. Appointment of Auditor for the year ahead**

Resolution 8: That the Glen Eden Business Association appoint McLaren Guise as Auditor for the Glen Eden Business Association for the 2023/2024 financial year.

**8. Election of Committee Members:**

Nominations for the Committee are to be announced. An election of members for the Committee shall be carried out in accordance with rule 14 of the constitution.

Resolution 9: That the Glen Eden Business Association approves the appointment of all elected members to the Committee for 2023/2024.

Nominations and elections for Chairperson, Treasurer and Secretary shall be carried out in accordance with Rule 15 of the Constitution and will be done at the first Committee meeting following the AGM.

Resolution 10: That subject to the election at the first Committee meeting following the AGM, the Glen Eden Business Association approves the appointment of the Chairperson, Treasurer and Secretary for 2023/2024.
